DIRECTIONS FROM I-77 NORTH (BLYTHEWOOD):

Take the SC-34 W. Exit (Exit 34), toward Winnsboro. Turn left onto SC Highway 34 W. Turn right at the stop sign. Stay in the right lane and follow the road about 3 miles until you reach Wilson Chrysler Dealership on the left. You will see a gas station (Gaz Ba), also on the left, and beside that is the Christ Central Community Center (235 S. Congress Street), where our meeting will take place.
